

RECOMMENDATION

Summary of Nominee's career / actions exemplifying the criteria standards:

Career Overview

For more than 30 years Steve Padula has been devoted to the hydropower licensing, relicensing, and compliance industry and is nationally recognized in this field. Steve obtained his Master of Science degree in natural resource development from Michigan State University. He was first introduced to the hydropower industry when he became employed by the Federal Energy Regulatory Commission (FERC) in the hydropower division. After some time in the hydropower industry he decided to venture out and became employed by Shell Oil, only to return to hydropower in 1986, where he took a position managing relicensing and license compliance for Central Maine Power Company's (CMP's) 30 hydropower and water storage projects. While with CMP, Steve was responsible for completing applications for 13 "Class of 1993" relicensings, completing four additional post-Electric Consumers Protection Act (ECPA) relicensing proceedings, and providing permitting and compliance support for redevelopment and rehabilitation projects. In 1995, he was one of the founding partners of Long View Associates, a small consulting firm with unique expertise in the area of FERC hydropower licensing, relicensing, and compliance. For nearly 18 years, he and his team helped clients address challenging FERC regulatory issues and provided licensing services. In 2013, he brought his team to McMillen Jacobs Associates, where he has served as Regulatory and Natural Resources Practice Lead. Steve is an active member of the Northwest Hydropower Association (NWHA) and has served on the NWHA Board for more than 8 years (2011-present; 1994 and 1995). He has served as Vice President and is the current Board President.

He is a frequent contributor of articles to hydropower publications on diverse topics of interest and importance to the industry. He is a tireless and avid supporter of NWHA, National Hydropower Association (NHA), and other organizations dedicated to the promotion of hydropower. He has consistently contributed to NWHA's efforts to make information available to the industry and has contributed significantly to the development of databases and other industry resources and information. Steve has a depth of knowledge of the hydropower industry and is always willing to engage on that subject. Throughout his career he has been dedicated to promoting hydropower as a clean, renewable source of electricity.

In Steve's many roles – department head, Board member and association president, small business owner, committee chairperson, co-worker, project manager, and trusted advisor – he is consistently also a mentor and supporter of all parties, his fellow teammates, and industry colleagues. Steve truly supports and wants to see those around him do well and succeed – personally, professionally, and to the benefit of the greater industry. He is always driven by a collaborative team approach and leads by example while pushing others to excel, grow, and see things in a new light. This can best be seen through the eyes of his client, colleague, and longtime friend:

"Steve exemplifies many of the attributes that we remember from our late colleague Pam Klatt. He is first and foremost an educator. He helps both his clients and his staff understand how to address a challenge but also why the issue should be addressed. Every challenge is a teaching moment. I can still remember watching Steve standing at the head of the Metolius River one summer evening many years ago briefing a congressional staff tour about how FERC licensing really works. We were guests of the Samuel Johnson Foundation standing under some of the largest Ponderosa Pines in Central Oregon at the head of one of Oregon's great rivers as it emerged fully formed from the springs of central Oregon. He held the group in rapt attention as if he was revealing the 10 Commandments for the first time. He completely dominated his competition, which if I remember was a wash tub full of ice cold beer and the most amazing hatch of stone flies and actively feeding rainbow trout.

As an NWHA board member, I have had the pleasure to work with Steve as he brings his experience to bear in this organization. In his role as NWHA Board President, he motivates the Board through his hard work and has engaged the organization successfully in looking at how we will provide our members with the most value going forward. I have been especially appreciative of the leadership that Steve has provided in establishing the Julie A Keil Women in Hydro Scholarship in honor of our longtime friend and colleague that Steve and I worked with for many years.

If I had to pick just one special lesson from the 20 years I've worked with Steve, it would be the importance of silence in managing meetings. Steve has an impeccable sense when facilitating a meeting to know when to just "hush up". He will pose a question and wait. The natural desire to resolve the tension by eliminating the silence by rewording a question or moving on to another question is hard to fight. But Steve feels it lets folks off the hook without resolving the issue. So he stands there with a peaceful smile on his face, till someone steps up. Amazingly effective.
